
#### Let us Introduce Ourselves!



McConnell AFB FamCamp has a total of 20 RV sites: 10 full hook-up sites and 10 partial hook-up sites. Other amenities include primitive tent camping areas, coin operated laundromat, shower and restroom facilities, and 2 fishing ponds. Reservations may be made up to 90 days in advance by phone or person.

# McConnell AFB FamCamp Resident Guidelines

Any violation of the rules will first result in a verbal warning. With a second violation you will be asked to vacate the park within 24 hours. If you have any questions regarding the rules, please come to the office and we will be happy to help.

- 1. Payment for reservation is due upon making the reservation
- 2. Cancellations made within 24 hours of the reservation date will be charged a one-night fee.
- 3. RV spots are available to stay up to 180 days upon space availability.
- 4. Primitive tent spaces are available to stay up to 60 days. Extensions beyond 60 days are not permitted.
- 5. Primitive camping is closed during winter months when temps drop below 35 degrees.
- 6. All customers are responsible for maintaining and keeping their assigned camping areas clean at all times.
- 7. Registration permit must be displayed in a visible location, facing the street, on the RV, trailer, or tent.
- 8. Children 10 years of age or younger must always be accompanied by an adult sponsor (18 years or older) during their stay in the campground.
- 9. All vehicles, trailers, equipment, etc., will be secured when unattended. The USAF and 22 FSS are not responsible for lost, stolen, or damaged property.
- 10. All vehicles (to include any motorized vehicle), utility trailers, boats, boat trailers, and jet skis must have current registrations and insurance.
- 11. The consumption of alcoholic beverages in the recreation areas by anyone under the age of 21 years is prohibited.
- 12. Dumping of "gray" water, petroleum products, solvents, pesticides, chemicals, etc., are prohibited in the fishing pond.
- 13. Customers can contact the ODR staff for assistance in disposing of items like pesticides, solvents, etc.
- 14. Individual clothes drying lines are prohibited in all campground areas.
- 15. RVs are prohibited from being washed on site.
- 16. Guests of customers cannot stay overnight in the campground unless they are staying in the same RV or tent as the eligible customer.

- 17. Swimming and wading in the fishing ponds are prohibited.
- 18. Fishing is permitted with a Kansas State Fishing license.

#### **Pet Guidelines**

- 1. No more than 2 four-legged pets are allowed by a FamCamp primitive camping customer at any given time. (ODR may approve exception to the policy)
- 2. All pets must have current immunizations
- 3. Pets must be accompanied the entire time they are outside the RV and on a leash.
- 4. Pets must never be left unattended in closed vehicles during extreme heat conditions.
- 5. Guests are responsible for immediately collecting, bagging, and then disposing of pet waste in the dumpsters.

# **Campfire Guidelines**

- 1. Campfires are only authorized in the FamCamp/primitive campground barbeque grills and/or fire rings.
- 2. Campfires are only allowed when the fire danger level is determined to be "low" to "high" with specific restrictions on the wind speed and direction provided.
- 3. If the fire restrictions are "Very High" or "Extreme", open fires will not be allowed. All open fires must be extinguished immediately.
- 4. Open flames must be monitored at all times. A bucket of water or sand must be in close proximity to aid in dousing the fire.
- 5. Please refer to weather.gov/ict/fire for current conditions.

### **Prohibited Items**

- 1. The possession of firearms, including BB and pellet weapons, is strictly prohibited on all campgrounds. Customers can contact 22<sup>nd</sup> Security Forces Squadron Base Defense Operations Center at (316) 759-3976 for guidance and control of such firearms.
- 2. Crossbows, underwater spear guns, hunting sling slots and blow guns.
- 3. Hunting.
- 4. Drones or Remote-Control aircraft
- 5. Fireworks or any incendiary items (i.e., rockets, flamethrowers, flares (except for road flares), etc.)

FamCamp 2- West of Slot 15/16

# Wildlife Depredation

Safety of flight is a top priority for the 22 Air Refueling Wing (ARW) and wildlife creates various hazards. The United States Air Force has partnered with the United States Department of Agriculture (USDA) to mitigate flight safety hazards. Fam Camp fosters an ideal habitat that attracts many wildlife species. Due to the location of Fam Camp, wildlife will cross over the active airfield to reach water, food sources, or shelter. Wildlife harassment and depredation are two methods that are commonly used to shift animals and birds away from the proximity of the airfield. The 22 ARW Flight Safety and the USDA have been granted federal and state permits that authorizes harassment and depredation of wildlife species that interfere with aviation safety.

Please do not be alarmed if you see USDA or 22 ARW Flight Safety personnel around the Fam Camp areas harassing or depredating wildlife. USDA personnel drives a white pick-up truck and will have "USDA" logos on their clothing. Wing Safety will be uniformed members in fluorescent yellow/green vests and will be driving a blue pick-up truck. Harassment and depredation efforts will only be conducted as official business. USDA and 22 ARW Flight Safety will take every precaution to ensure campers and patrons remain safe during these efforts.
